Problem 1:

(a) Prove (using the comparison test or the Weierstrass-M test) the \Cauchy root test": If $C = \limsup_{n! = 1} ja_n j^{1=n} < 1$, then the series

converges uniformly if |z| < 1=C and diverges if |z| > 1=C.

(b) What does this result say about the series

$$\bigotimes_{\substack{n=0}}^{N} 2^n \sin(n) z^n$$

Problem 2: (The two sub-problems are unrelated)

- (a) One of the requirements of the Weierstrass Approximation Theorem is that the function to be approximated is continuous on a closed and bounded interval *I*. Show that the Approximation Theorem does not hold if we replace *I* by a bounded open interval (a; b) by showing that if $f(x) = 1 = (b \ x)$, then $f: (a; b) \neq \mathbb{R}$ cannot be uniformly approximated by polynomials.
- (b) Let $(e_n)_{n \ge N}$ be an orthonormal basis for a Hilbert space H and $A : H \nmid H$ a bounded linear operator. If

then prove *A* is a compact operator.

Problem 3: Let (X; d) be a complete metric space. A function $f : X \neq X$ is said to be a contraction if there exists c < 1 such that d(f(x); f(y)) = c - d(x; y) for all $x; y \geq X$. A function f is said to be a *weak contraction* if

$$d(f(x); f(y)) < d(x; y) \quad 8 x \in y; x; y \ge X:$$

Note that a weak contraction is Lipschitz continuous with Lipschitz constant 1.

- (a) Prove the following variant of the contraction mapping theorem: if f is a *weak contraction* and the space X is *compact*, then f has a unique xed point in X. Hint: consider the function g(x) = d(x; f(x)) over X.
- (b) Let X be ${}^{2}(\mathbb{N})$ and f(x) = L(x) + b be an a ne function de ned by mapping $L : x \mathbb{V} \ y$ where $x = (x_n)_{n \ge \mathbb{N}}$ and $y = (y_n)_{n \ge \mathbb{N}}$ with $y_n = (1 \quad \frac{1}{n})_{x_n}$ and $b = (\frac{1}{n})_{n \ge \mathbb{N}}$. Prove or disprove that f has a xed point in X. Does your answer change if X is the closed unit ball in ${}^{2}(\mathbb{N})$?

Problem 4: Let *H* be an in nite dimensional Hilbert space, and *M* a subspace of *H*. If ' 2M, prove ' has a *unique* norm-preserving extension to a bounded linear functional on all of *H*, and that this extension vanishes on $M^{?}$.
